

# AS/NZS 1288 Accredited workshops

The Technical pillar of the Accredited Company Program ensures that companies have staff who have a thorough understanding of the AS/NZS 1288 standard 'Glass in Buildings Selection and Installation'



To maintain Accredited Company status a minimum of one (1) staff member must have satisfactorily completed the AGGA AS/NZS 1288 Accredited program.

## AS/NZS 1288 Accredited Program

Knowledge of the AS/NZS 1288 standard is an important pillar of the Accredited Company Program. While the minimum requirement is for one staff member to have completed the program, some companies are training multiple staff to this level of expertise, because of the added value to their business.

To maximize the number of glaziers who achieve this accredited level of technical understanding, AGGA has developed a range of educational pathways.

The AS/NZS 1288 Accredited assessment is designed so that participants can demonstrate their understanding and ability to apply it in a real work scenario. There are no prerequisites to attend the program.

## AS/NZS 1288 Accredited Workshops

These workshops are delivered by experienced glass professionals and comprise of a full day of approximately 7 hours 9.00am – 4.00pm.

NOTE: Students must bring their own copy of AS/NZS 1288 for use in the workshop.

## CPD Points

AGGA recognises the importance of Continuing Professional Development (CPD) and if you attend the workshop only, you will be eligible for 2 CPD points. Successful completion of the program will ensure you are eligible for an additional 3 CPD points.

In-person workshops (including the portfolio) cost \$250 for members and \$400 for non-members.
